Franchise Policy of Galaxy Diagnostics Lab

- 1. The attached form must be filled completely.
- 2. The given data must be correct, in case of any wrong information; franchise ownership will not be issue.

Franchise Branding: (This clause should be full filled)

- 1. Proposed location for the collection center should have an area of minimum 400 sq. ft. with minimum 15 ft. front
- 2. Preference will be given to the person belonging to same area in which he/she is looking for a collection center.
- 3. For Franchise Branding one should meet following criteria (Branding pictures annexed):
 - Reception Table (Dimension: L 60", D 24", H 43") with the logo in center.
 - Grey Sheet behind reception table on Wall with light shading from above. (Approved back ground Grey Covering and PVC round approved Logo with the name on sheet).
 - Phlebotomy Table with white sheet with all sample collection items.
 - White Paint on Walls and white sealing on roof with white tiles on ground.
 - Grey Line Stickers around the wall equal to height of table.
 - Cupboard of grey and white sheet.
 - Table for Centrifuge and other accessories should be of white sheet.
 - Water Cooler with Disposable glass.
 - Air Conditioner.
 - 01 stool for Phlebotomy and 01 chair for reception table with sitting sofas for patients.
 - CPU and Printer with Internet Facility 24/7.
 - Glass/ Aluminum Door with Branding Stickers.
 - Main LED Light Sign Board with Main Flex with approved Design.

Note: Any discrepancy or alter in provided Franchise Branding will breach the contract

Eligibility Criteria:

Franchise Applicant - Eligibility Criteria must be full filled.

• Anyone can apply but preference will be given to those with adequate financial resources to sustain through the breakeven period and with business know how / acumen



- A bank statement for the past six months with an available account balance of PKR 10,00,000/- (PKR 01 Million), transaction activity during the six months will also be evaluated. Applications received without the copy of bank statement will not be entertained
- Proposed location for the collection center should have an area of minimum 400 sq. ft. Page | 2 with minimum 15 ft. front
- Preference will be given to the person belonging to same area in which he/she is looking for a collection center
- He/she should be permanently settled in Pakistan
- Galaxy diagnostic Lab employees including their spouse and blood relations are not eligible to apply.
- Ex-employees of Galaxy diagnostic lab are also not eligible to apply before the completion of a period of six months from the time of cessation of their service
- Sub-contractors are not allowed

Franchise Approval:

A committee will interview each applicant for assessment and approval of franchise.

Processing Fee:

GDL has policy of same standard and outlook at each franchise. We will charge security deposit amount for franchise, fee for franchise PKR: 100000/-(PKR 0.1 Million) not refundable, will be charged for the following:

- 1. Online software access
- 2. Marketing Materials (Brochers , Standing flexes etc)
- 3. Stationery (envelops, file folders etc.)
- 4. Training to franchiser and Certificate of Training.
- 5. Free medical camps for three months (one parameter in a week)
- 6. Registration fee (Lab will itself arrange registration for the franchise)
- 7. Racks for voiles

Free For one month after that the following items will be charged according to market rates

- Syringes
- Voiles
- Labels (on Voiles)
- Swabs
- Culture bottles etc

Renovation and Location of center:

- ALL renovation cost of the center will be paid by the franchise owner.
- Location of the center should be clearly visible, preferably near to/inside any hospital.
- In 3 km circle lab will not entertain any other franchiser or center.

Discount policy for franchise owner:

1. Total discount for the franchise will be 50% on standard price list.



- 2. If lab will refer its doctor/referral party to the franchise in its area, the franchise will get total 20% discount instead of 50%.
- 3. Any other kind of discounts will not be allowed by the laboratory.
- 4. Any discount to the patient by franchise will be exclusively by franchise side.

Note: Referral doctor name must be mentioned.

Incentive policy:

Lab will also offer extra incentive other than decided discount on achievement of targets. (This will be according to the volume of business.)

Other services from lab:

- 1. Collection of samples inside Lahore will be responsibility of laboratory.
- 2. Outside the Lahore, transportation will be through other courier (TCS/OCS/Leopard courier/Daewoo) and payment of that courier will be paid by the franchise or referral center.
- 3. Backup system for this will be provided by the lab.
- 4. Any Franchise complains and Reports will be resolved directly by the lab.

Payment mode:

Payment should be deposited with sample or bill will be paid by franchise/center on the day end by any means, otherwise reports will be blocked.

Check and balance policy:

- 1. Lab is authorized to check and audit of franchise any time.
- 2. A crossed cheque will be taken according to the agreement.
- 3. In case of any fraud, misconduct, misuse of lab name or violation of SOP's, a penalty will be charged to the franchise, and for the said purpose a crossed cheque will be deposited by the franchise. This cheque will be not refundable in case of penalty.

All the above SOP's are written and decided for maintained a good brand and standard of Lab. These are general terms applicable to all franchisers.
